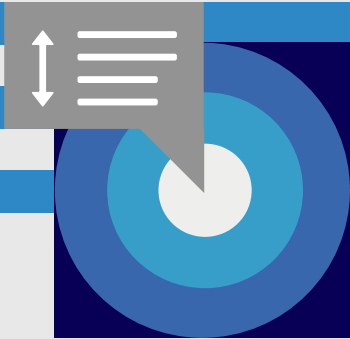

Evaluation Methods Used: Automated axe-core scanning and manual expert review, including keyboard-only navigation, screen reader testing (NVDA and VoiceOver), and manual code inspection.

Evaluation Summary:

Of the 56 WCAG 2.2 Level A and AA success criteria evaluated, 35 fully support the criterion, 5 partially support it, 1 does not support it, and 15 are not applicable to the pages and functionality evaluated. Detailed findings and remediation guidance for each criterion are provided in the table below.
